Article 4 Direction

Land at the Junction of Beach Road and Richmond Street, Weston-super-Mare

WHEREAS the Woodspring District Council being the District Planning Authority for the District of Woodspring (hereinafter called "the Council") are the appropriate Local Planning Authority within the meaning of Article 4 of the Town and Country Planning General Development Orders 1977 to 1981 and are satisfied that it is expedient that development of the description set out in the Schedule hereto should not be carried out on land at the junction of Beach Road and Richmond Street, Weston-super-Mare, being the land shown edged red on the plan annexed hereto, unless permission therefor is granted on application made under the Town and Country Planning General Development Orders 1977 to 1981

AND WHEREAS the Council are of the opinion that development of the said description would be prejudicial to the proper planning of the area and would constitute a threat to the amenities of the area and that the provisions of Paragraph (3)(b) of the said Article 4 should apply to this Direction.

NOW THEREFORE the Council, in pursuance of the powers conferred on them by the said Article 4, hereby direct that the permission granted by Article 3 of the Town and Country Planning General Development Orders 1977 to 1981 shall not apply to development on the said land of the description set out in the Schedule hereto.

This Direction is made in pursuance of the provisions of Paragraph (3)(b) of the said Article 4 and shall remain in force until the 6th January 1984 (being six months from the date of this Direction) and will then expire unless it has been approved by the Secretary of State for the Environment before that date,

Any development of the kind specified in Paragraph 2 of Class IV of the First Schedule to the 1977 Order being:-


CLASS IV

The use of the land (other than a building or the curtilage of a building) for any purpose or purposes except as a caravan site on not more than 28 days in total in any calendar year (of which not more than 14 days in total may be devoted to use for the purpose of motor car or motor-cycle racing or for the purpose of the holding of markets), and the erection or placing of moveable structures on the land for the purpose of that use

and not being development comprised within any other Class


