Clevedon (Triangle) Conservation Area (Direction No. 1)

WHEREAS the Woodspring District Council being the District Planning Authority for the District of Woodspring (hereinafter called "the Council") are satisfied that it is expedient that the development set out in the Schedule here to should not be undertaken within the areas identified as being part of the Clevedon (Triangle) Conservation Area (adopted and designated by the Woodspring District Council on the 12th March 1981) unless permission therefor is granted on application made under the Town and Country Planning General Development Orders 1977 to 1981: the Conservation Area is shown by a solid black line on the plan annexed here to and the properties to which this Direction relates are shown by hatching within the thin black line.

AND WHEREAS the Council are of the opinion that development of the said description would be prejudicial to the proper planning of the area and would constitute a threat to the amenities of the area and that the provisions of Paragraph 3(b) of the said Article 4 of the Town and Country Planning General Development Order 1977 should apply to this Direction.

NOW THEREFORE the Council, in pursuance of the powers conferred on them by the said Article 4, hereby direct that the permission granted by Article 3 of the said Orders shall not apply to development within the said area of the description set out in the Schedule hereto.

This Direction is made in pursuance of the provisions of Paragraph 3(b) of the said Article 4 and shall remain in force until the force of the Direction and will then expire unless it has been approved by the Secretary of State for the Environment before that date.
