TOWN AND COUNTRY PLANNING GENERAL

DEVELOPMENT ORDER, 1963

Land adjoining the Bristol - Exeter Trunk Road, A.38 at Winscombe

WHEREAS the Somerset County Council being the Local Planning Authority for administrative County of Somerset (hereinafter called "the Council") are satisfied that it is expedient that the development set out in the Schedule hereto should not be undertaken on the land shown coloured pink on the plan annexed hereto unless permission therefor is granted on application made under the Town and Country Planning General Development Order, 1963

NOW THEREFORE the Council in pursuance of the powers conferred on them by Article 4 of the Town and Country Planning General Development Order, 1963, hereby direct that the permission granted by Article 3 shall not apply to development on the said land of the description set out in the Schedule hereto

SCHEDULE

Any development of the kinds specified in paragraph 1 of Class VI of the First Schedule to the said Order being:-

The carrying out on agricultural land having an area of more than one acre and comprised in an agricultural unit of building or engineering operations requisite for the use of that land for the purposes of agriculture, other than the placing on land of structures not designed for those purposes or the provision and alteration of dwellings.

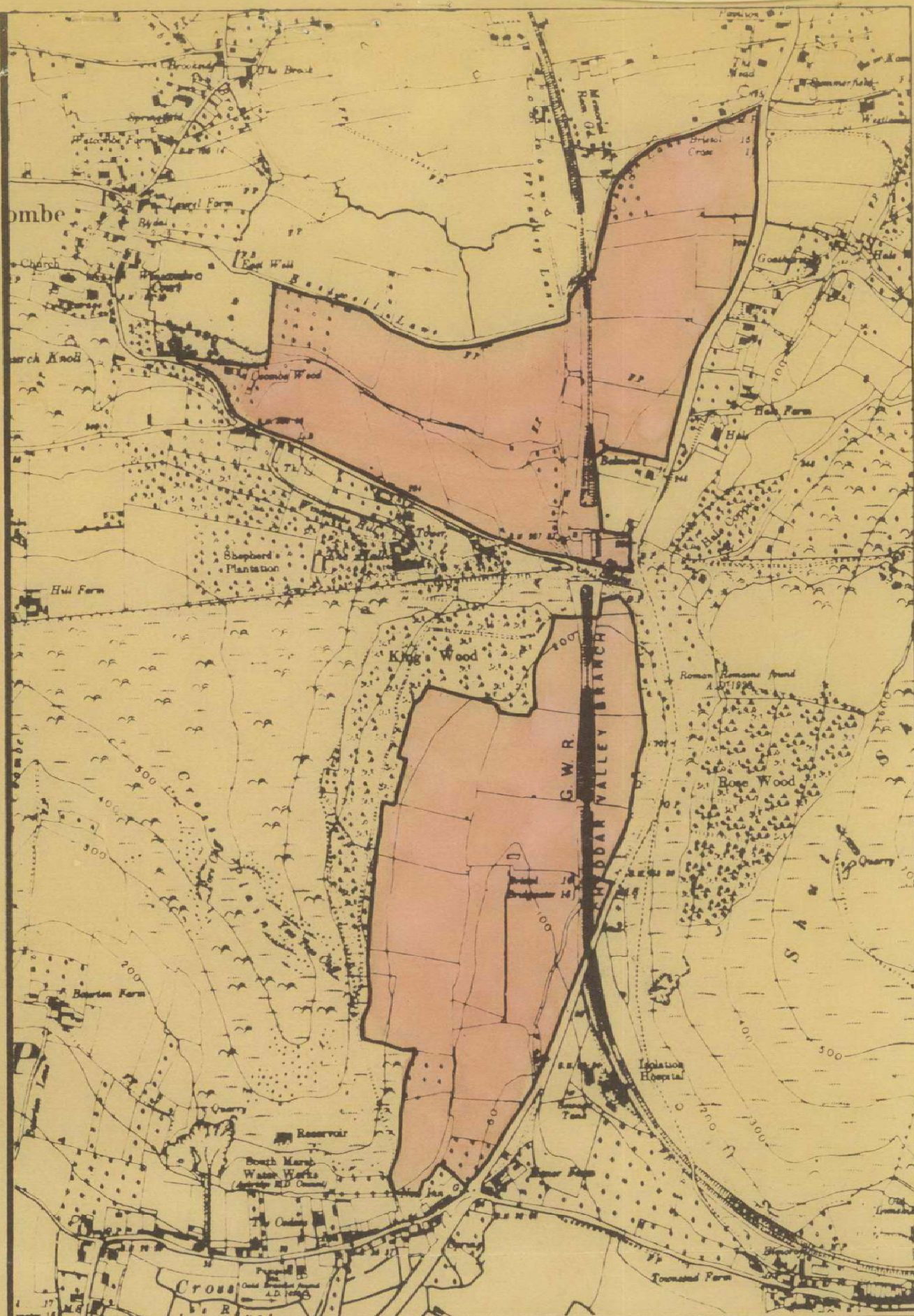
