



## National offer day (16 April 2019)

St Joseph's Catholic Primary School has an admission number of 30.

102 preferences have been received for the school. It has, therefore been necessary to use the oversubscription criteria, as outlined below, to determine which of the applicants should be offered the places available.

The 30 available places have been offered to the following applicants:

The distance between home and school for the last child offered a place was 1.095 miles.

Any appeals for places at the school are therefore 'infant class size prejudice cases'.
