Becket Primary School has an Admission Number of 30. 64 applications have been received for the school. It has, therefore been necessary to use the oversubscription criteria, as outlined below, to determine which of the applicants should be offered the places available.

The 30 available places have been offered to the following applicants:

Where a school is named in a child's Statement of Special Educational Needs Education or Health and Care Plan, the admission authority is legally required to admit the child to the school. Therefore such children are allocated places before the criteria, detailed below, are applied.

	The school is named in a Statement of Special Educational Needs or Education Health and Care Plan.	0 children
i	Children in Care at the time of application and children who were previously in Care but ceased to be so because they were adopted (or became subject to a child arrangements order or special guardianship order) immediately following having been in Care.	0 children
ii	Children with a brother or sister who will be attending the school at the time of admission.	12 children
iii	Children, where it is the nearest school to their home address, who live more than a distance of 2 miles from that school measured by the shortest available walking route.	0 children
iv	Children living nearest to the school.	19 children

The distance between home and school for the last child offered a place was 0.666 miles.

1 additional child was offered a place due to being a permitted exception (as per section 2.15 of the School Admissions Code) to the infant class size legislation.
