St Georges Church School has an Admission Number of 30. 64 applications have been received for the school. It has, therefore been necessary to use the oversubscription criteria, as outlined below, to determine which of the applicants should be offered the places available.

The 30 available places have been offered to the following applicants:

Where a school is named in a child's Statement of Special Educational Needs Education or Health and Care Plan, the admission authority is legally required to admit the child to the school. Therefore such children are allocated places before the criteria, detailed below, are applied.

	The school is named in a Statement of Special Educational Needs or Education Health and Care Plan.	0 children
1	A 'looked after child' or a child who was previously looked after but immediately after being looked after became subject to an adoption, child arrangements, or special guardianship order. A looked after child is a child who, at the time of application, is (a) in the care of a local authority, or (b) being provided with accommodation by a local authority in the exercise of their social services functions (section 22 (1) of the Children Act 1989 applies).	0 children
2	Children who have a sibling attending St Georges Church School at the time of application, who will still be on roll at the time of admission and who lives at the same home address.	13 children
3	Children who live within the Civil Parish of St Georges or with a confirmed move to a home address within this parish, available at the time of application.	17 children

The distance between home and school for the last child offered a place was 0.285 miles.
