#### Update on 22<sup>nd</sup> June 2018

0 places became available due to parents not accepting the offer of a place. 13 applications were considered for places.

To admit another child to the school would cause prejudice to the provision of efficient education or the efficient use of resources by reason of 'relevant measures', i.e. measures that would be required to be taken in order to ensure that the legal limit on class sizes of one teacher per 30 children is met at the school. Any appeals for places at the school are therefore 'infant class size prejudice cases'.

# Update on 3rd July 2018

1 additional child was offered a place due to being a permitted exception (as per section 2.15 of the School Admissions Code) to the infant class size legislation.

This is due to a procedural error in the second round of allocations (update on 4<sup>th</sup> June) where 1 child was considered under criterion f) incorrectly, instead of criteria g).

The child who was wrongly refused a place has now been offered from criteria g) with a direct line distance between home and school of 0.191 miles.
