# **DECISION NO. 16/17 DE 39 UPDATE TO 16/17 DE 283**

#### **SUBJECT:**

Officer Authorisation: Streets & Open Spaces/Highways and Transportation.

#### **Background:**

Local Authorities must ensure that their officers are duly authorised to act on behalf of the authority.

#### **DECISION:**

That the North Somerset officers listed in Appendix 2 be authorised to act on behalf of the Council in performance of their duties with respect to the legislation listed in Appendix 1; this includes all aspects of inspection, investigation, enforcement and formal action. Community Response Officers working for North Somerset Council and in partnership with Avon and Somerset Police will provide a joined approach to enforcement in North Somerset.

#### Reasons:

Failure to duly authorise officers will result in the authority being unable to discharge its statutory functions. This will have a significant impact upon other corporate priority work areas, for example, crime and disorder and environmental enforcement.
