UPDATE TO DECISION NO. 15/16 - 16/17 DE 267

SUBJECT: Authorisation of Officers to enter land or buildings.

Background:

The Council's Constitution delegates to the Director of Development and Environment, the exercise of all the functions (including the authorisation of officers) of the local planning authority and the mineral planning authority.

It is necessary to authorise officers to enter land for any of the purposes and in accordance with the provisions of Sections 196A, 196B, 214B, 214C and 324 of the Town and Country Planning Act 1990 (as amended); Sections 88 and 88A of the Planning (Listed Buildings and Conservation Areas) Act 1990; Section 24 of the Local Government (Miscellaneous Provisions) Act 1976; Section 74 of the Anti-social Behaviour Act 2003, and Sections 45,47,79 and 85 of the Anti-Social Behaviour, Crime and Policing Act 2014.

DECISION:

1. That the officers listed in the schedule to this decision are authorised to enter land and buildings for any of the purposes and in accordance with the provisions of Sections 196A, 196B, 214B, 214C and 324 of the Town and Country Planning Act 1990 (as amended); Sections 88 and 88A of the Planning (Listed Buildings and Conservation Areas) Act 1990; Section 24 of the Local Government (Miscellaneous Provisions) Act 1976; and Section 74 of the Anti-social Behaviour Act 2003.
2. That the Head of Development Management is authorised to exercise my delegated powers to add to or amend the list of officers authorised to enter land and buildings as necessary.
3. That the Head of Development Management is authorised to sign warrant cards to be produced to members of the public by authorised officers when exercising powers to enter land and buildings.

Reasons:

To allow the officers named to access private land and buildings to the extent necessary to fulfil their duties in accordance with the Acts listed above.
