This decision is being taken under the urgency/emergency powers provided in the officer delegations in the Constitution – General Director powers para 2.2:

To take emergency action on behalf of the Council on any matter in cases of urgency or emergency with, wherever possible, prior consultation with the Chief Executive and Director of Corporate Services and the Executive Member and the Chairman of the appropriate Policy and Scrutiny Panel or Committee and Subject to a report as soon as possible afterwards to the appropriate body.

SUBJECT: CAR PARKING MANAGEMENT IN RESPONSE TO COVID-19

KEY DECISION: YES

REASON: This decision affects communities across North Somerset.

BACKGROUND:

The key message in addressing the coronavirus pandemic is to maintain social distancing. Recent activity by the public has demonstrated that this message has not reached everyone, and our car parking arrangements have not helped to support this message. For example, keeping car parks open in desirable locations sends the wrong message because it enables people to congregate either in the car park or close to it, directly contradicting the social distancing we should be encouraging. For example, the weekend of 21 March 2020 was extremely busy on Weston promenade and seafront.

These issues raise questions about how we should manage our car parking across North Somerset and this report describes the Council's response.

Removing parking charges is considered an action that will encourage the movement of people and so it is proposed that they will remain.

We are concerned about the personal contact staff receive during enforcement activities. We will therefore maintain a demand responsive team of 1 or 2 staff to deal with the most serious parking incidents and to address any operational safety issues that arise alongside keeping ticket machines in working order.

It is also proposed to close the car parks listed below which are considered to be popular car parks that enable high numbers of people to congregate.

1) To keep in place our current scheme of charges but to focus enforcement on addressing dangerous parking issues

2) That the car parks and other sites listed below are closed from 24 March 2020 until further notice.

FINANCIAL IMPLICATIONS:

Costs

Based on previous periods the potential implication could be £600k lost income for the first quarter of 2020/2021 financial year.

However, the lockdown announced by the government on 23/3/2020 severely restricts movement and actively encourages people to stay at home. This means that the reduced income is probable in any event.

However, by closing the car parks the Council is sending a clear message about supporting social distancing which is particularly relevant at these locations which have proven to be a significant draw for people.

Funding

The funding to close the car parks will be met by revenue budgets as will maintaining the physical barriers.

Under Part ii- Authorisation and use of parking places

Section 13: Nothing in this order shall prevent the Council by notice, sign or barrier displayed in the Parking Place;

(i) from closing the Parking Place or any part or parts thereof for any period; and / pr
(ii) from setting aside the Parking Place or any part or parts thereof on all days or on certain days or during parts of days for use only by certain vehicles. Persons

(Part (ii) is being used to allow residents access through Knightstone Causeway car park and for the Old Colonial access through Melrose car park)
