DECISION NO. 15/16 - 16/17 DE 268

SUBJECT: Officer Authorisation Building Control

Background:

All officers and Contractors who enforce legislation delegated to the Development and Environment Directorate, Operations, and who work within or on behalf of the Building Control Service team must be duly authorised to act on behalf of the authority. Since the previous authorisations there have been changes in legislation and personnel. Accordingly all relevant staff within the team must be duly authorised for all of the relevant legislation. This is an updating exercise which ensures that staff can undertake the wide variety of inspections and investigations that they may be expected to initiate and can follow up with formal action where required as part of a wider enforcement team.

DECISION:

That the North Somerset officers listed in the appendix be authorised to act on behalf of the Council in performance of their duties with respect to the legislation listed in appendix 1; this includes all aspects of inspection, investigation, enforcement and formal action.

Reasons:

To ensure that the Council's officers and Contractors listed in the appendix are duly authorised and can undertake statutory duties on behalf of the authority.

Other Alternatives Considered:

There is no alternative as failure to authorise would compromise the ability of the Council to perform its statutory functions.
