### **DECISION OF:** THE DIRECTOR OF DEVELOPMENT AND ENVIRONMENT

# WITH ADVICE FROM HEAD OF HR AND UNIONS



**DECISION NO:** 19/20 DE 387

**SUBJECT:** Car parking management in response to COVID-19 and lifting of restrictions following Government announcement on 10 May 2020

This is an urgent key decision and the public notice procedure has been followed.

**KEY DECISION:** Yes.

**REASON:** This decision effects communities across North Somerset.

### **BACKGROUND:**

Decision 19/20 DE 341 approved the closure of car parks across North Somerset which were considered to be enabling high visitor numbers which contributed to the contravention of social distancing requirements. Other measures included car parking charges should remain, but enforcement would focus on the most serious parking incidents.

With the Prime Minister recently announcing the country moving to Covid Alert Level 3, and subsequent relaxation of some of the lockdown measures, it is anticipated that there will be more visits to North Somerset, especially our coasts.

Without having the facility to prevent these visits it will be necessary to have places for people to park to prevent potential transport disruption for visitors and residents. A limited opening of car parks is also in line with other organisations such as the National Trust and Forestry Commission.

It is possible to open the car parks listed in Table 1 with 24 hours' notice. This will enable enough time to organise signage, social distancing guides and prepare ticket machines.

It is not proposed to open parking on Marine Parade, Uphill and Weston super Mare beaches and Kilkenny Fields Portishead because this will provide more space to support social distancing measures and also send the message that the Council is not proactively "reopening" its coastal areas.

It is proposed to introduce a 2 week 'soft' enforcement period where warning notices are used for contraventions instead of actual tickets. A repeat offence will generate a Penalty Charge Notice (PCN). All dangerous parking will continue to automatically receive a PCN. Full enforcement will resume after 2 weeks. It is also proposed that NHS, care home workers and North Somerset Together volunteers will be exempt from parking charges and time restrictions until 30 June 2020.

Enforcement will be subject to staff maintaining social distancing which will be underpinned by an appropriate risk assessment.

Other measures include reducing the use of cash payments. It is proposed that we do not allow cash payments in any of the car parks that we are re-opening and reduce the number of ticket machines in car parks that have remained open. This will reduce the need to touch surfaces and cash that can both transmit the virus thereby making it safer for visitors, our staff and contractors; and it is common for most transactions during the COVID crisis. This will also have the benefit of introducing the concept of cashless payments for car parking to a wider audience.

The same principles will apply to on-street parking to try and avoid congestion and other transport issues if people try to avoid paying at off street locations and choose to park on the streets.

A detailed explanation of the operational implementation of these proposals can be found in Appendix A.

# **DECISION:**

- 1. To keep in place our current scheme of charges and to re-introduce full enforcement of parking restrictions by 27 May 2020.
- 2. To only allow cashless payment in the car parks listed below where charges apply. This will be kept under review particularly in relation to equalities groups.
- 3. That the car parks and other sites listed below are open from 13 May 2020.

- 4. To exempt NHS staff, care home workers and North Somerset Together volunteers from parking charges and time restrictions until 30 June 2020
- 5. To reintroduce the measures laid out in Decision 19/20 DE 341 if the Government's Covid Alert Level reverts to more restricted movement

## Costs

Currently, payments via MiPermit generate a 10p 'convenience' fee to the ticket buyer. It is proposed that the Council covers this cost because we are forcing visitors to use MiPermit. It is estimated this cost, based on last year's income, is £2000 per month. Some of this will be offset by fewer cash collections. More detailed financial analysis will follow.

The cost for signage and other safety measures are estimated at £2000.

# **Funding**

The lockdown restrictions have significantly impacted parking income. However, reopening the car parks now will help to stop this shortfall. The MiPermit fee and signage will need to be funded from the income generated through the parking revenue budget

## **LEGAL POWERS AND IMPLICATIONS**

The current off street parking order is:

North Somerset District Council (Various sites) (Off-street parking places) (Consolidation order) order 2017 (variation 2)

Under Part ii- Authorisation and use of parking places

Section 13: Nothing in this order shall prevent the Council by notice, sign or barrier displayed in the Parking Place;

(i) from closing the Parking Place or any part or parts thereof for any period; and / pr (ii) from setting aside the Parking Place or any part or parts thereof on all days or on certain days or during parts of days for use only by certain vehicles. Persons (Part (ii) is being used to allow residents access through Knightstone Causeway car park and for the Old Colonial access through Melrose car park).
