Final Notice of Temporary Traffic Regulation Order 2020
Streamcross, Claverham, North Somerset
Temporary Prohibition of Use by Vehicles Order 2020
Date coming into force: 9 June 2020

Notice is hereby given that North Somerset Council in pursuance of the provisions of section 14 of the Road Traffic Regulation Act 1984, as amended, have made an order the effect of which will be to close, temporarily, to vehicles the lengths of roads specified in the Schedule to this Notice. Exemptions are included for emergency services, works access and as works permit for premises which may only be accessed via the closed section of road.

This order was required because of the likelihood of danger to the public consequent upon work by Bristol Water to replace a lead pipe. This will become operative on **9 June 2020** for a maximum period of 18 months. However, the closures may not be implemented for the whole of the period but only as necessitated by the works which is anticipated to be **3 days** in duration. Appropriate traffic signs will be displayed when the measures are in force.

Notice is hereby given that North Somerset Council in pursuance of the provisions of section 14 of the Road Traffic Regulation Act 1984, as amended, have made an order the effect of which will be to close, temporarily, to vehicles the lengths of roads specified in the Schedule to this Notice. Exemptions are included for emergency services, works access and as works permit for premises which may only be accessed via the closed section of road.

This order was required because of the likelihood of danger to the public consequent upon work by Wessex Water to repair a frame and cover (contact Wessex Water 01225 524 568). This will become operative on **18 June 2020** for a maximum period of 18 months. However, the closures may not be implemented for the whole of the period but only as necessitated by the works which is anticipated to be **1 day** in duration. Appropriate traffic signs will be displayed when the measures are in force.

Notice is hereby given that North Somerset Council in pursuance of the provision of section 14 of the Road Traffic Regulation Act 1984, as amended, has made an Order the effect of which will be to close, temporarily to vehicles, the length of road specified in Schedule 1 to this Notice.

This order is required for avoiding danger to persons or other traffic using the road arising from works to widen and resurface the road. This Order became operative on **2 December 2019** for a maximum period of 18 months. However, the authorisation may not be implemented for the whole of the period but only as necessitated by the works which is anticipated in this instance to be **Wednesday 10 June 2020** and **Thursday 11 June 2020** (between 8pm and 6am). When a closure is active, road closed signs will be displayed and a diversion system will operate.
