

**NORTH SOMERSET DISTRICT COUNCIL**

**(ALEXANDRA PARADE, ALFRED STREET AND LOCKING ROAD, WESTON-SUPER-MARE) (PRESCRIBED MOVEMENTS) (PROHIBITION OF MOVEMENTS) ORDER 201#**

The District Council of North Somerset (hereinafter referred to as “the Council”) in exercise of its powers under sections 1(1) and 2(1) to (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended (hereinafter referred to as “the Act of 1984”) and of all other enabling powers, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into operation on \*\*\*\*\* 201\* and may be cited as the North Somerset District Council (Alexandra Parade, Alfred Street and Locking Road, Weston-Super-Mare) (Prescribed Movements) (Prohibition of Movements) Order 201#
2. No person shall cause or permit any vehicle proceeding in the length of road specified in Schedule 1 to this Order to make a U-turn so as to proceed in the opposite direction.
3. No person shall cause or permit any vehicle proceeding in any of the roads specified in column 1 of Schedule 2 to this Order to enter the road specified in relation to that road in column 2 of the said Schedule.
4. The existing General Traffic Regulation Order cited as the North Somerset District Council (Various Roads, Weston-super-Mare, North Somerset) (General Traffic Regulations) (Consolidation) Order 2004 is hereby revoked insofar as it relates to the roads or lengths of roads specified in schedule 3 to this Order.

### **Prohibition of U-Turn**

#### **LOCKING ROAD –**

at a point approximately 12 metres west from the centreline of Jubilee Road junction at the end of the central island, whilst travelling in a west bound direction.

### **Prohibition of Entry**

<b>Column 1</b>	<b>Column 2</b>
<b>ALEXANDRA PARADE</b> north bound heading towards Alfred Street.	<b>ALEXANDRA PARADE</b> northern section heading east bound.
<b>ALFRED STREET</b> south bound heading towards Alexandra Parade	<b>ALEXANDRA PARADE</b> northern section heading east bound.

### **Revocation - One Way Traffic**

<b>ALEXANDRA PARADE</b> from its junction with Alfred Street to its junction with Locking Road	West to East
<b>ALFRED STREET</b> From its junction with Alexandra Parade to its junction with Locking Road	North to South
