

FINAL NOTICE

NORTH SOMERSET COUNCIL

(VARIOUS ROADS, PORTBURY, NORTH SOMERSET) (PROHIBITION OF HEAVY COMMERCIAL VEHICLES OVER 7.5 TONNES MAXIMUM GROSS WEIGHT) ORDER 2017

NOTICE IS HEREBY GIVEN that on the 21st December 2017 North Somerset Council made an Order under Sections 1(1) and (2), 2(4) and 3(2) and of Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended, (hereinafter referred to as "the Act of 1984") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, the effect of which will be to;

1. prohibit any vehicle exceeding 7.5 tonnes maximum gross weight to enter or proceed in the length of roads specified in the Schedule to this Notice.

Exemptions in the order permit any vehicle to enter and wait for the purposes of conveyance of goods or merchandise to or from premises on or adjacent to the road; agricultural or conveyance or haulage of timber; maintenance of the road; supply of gas, water or electricity; the pursuance of statutory powers or duties; postal services; garaging, servicing or repair; police, fire brigade and ambulance; and any public service vehicle or school bus.

The order will come into operation on 27th December and a copy thereof together with a map and a copy of the Council's Statement of Reasons for making the order may be inspected at the Highways and Transport Department, Castlewood, Tickenham Road, Clevedon BS21 6FW (callers should report to Reception and ask for the Highways Section quoting reference **VR Portbury/7.5T**) during normal office hours. Any person who desires to question the validity of, or of any provision contained in the order on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 as amended, or on the grounds that any of the relevant requirements of that Act has not been complied with in relation to the order, may within six weeks after the date on which the order was made, apply to the High Court for this purpose.

Priory Road	-	whole length.
Station road	-	from its junction with High Street, Portbury, until its end south of the M5, a distance of approximately 266 metres.
