

**FINAL NOTICE**

**NORTH SOMERSET DISTRICT COUNCIL**

**(VARIOUS ROADS, BACKWELL, NORTH SOMERSET) (PROHIBITION OF VEHICLES  
OVER 6 FOOT WIDTH) ORDER 2017**

NOTICE IS HEREBY GIVEN that on the 21<sup>st</sup> December 2017 North Somerset District Council made the following Order under Sections 1(1) and (2), 2(4) and 3(2), of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended, the effect of which will be –

1. Prohibit the movement of vehicles the width of which, inclusive of any load on the vehicle, exceeds six foot to proceed in the lengths of road specified in the Schedule to this Notice.

Exemptions in the order permit any vehicle to enter and wait for the purposes of conveyance of goods or merchandise to or from premises on or adjacent to the road; agricultural or conveyance or haulage of timber; maintenance of the road; supply of gas, water or electricity; the pursuance of statutory powers or duties; postal services; garaging, servicing or repair; police, fire brigade and ambulance; and any public service vehicle or school bus.

The Order will come into operation on the 27<sup>th</sup> December 2017 and copies thereof together with maps and a copy of the Council's Statement of Reasons for making the orders may be inspected at the Highways and Transportation Department, Castlewood, Tickenham Road, Clevedon, BS21 6FW (callers should report to Reception and ask for the Highways and Transportation Section quoting reference **VR Backwell/6FW** during normal office hours). Any person who desires to question the validity of, or of any provision contained in the order on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 as amended, or on the grounds that any of the relevant requirements of that Act has not been complied with in relation to the order, may within six weeks after the date on which the order was made, apply to the High Court for this purpose.

## **SCHEDULE**

### **Prohibition of Vehicles Exceeding 6 Foot Width**

**Backwell Hill Road** – extending from its junction with the A370 Farleigh Road, to its junction with Long Lane, a distance of approximately 237 metres.

**Hyatts Wood Road** – extending from its junction with Long Lane to its junction with Downside Road, a distance of approximately 1691 metres.
