## Update on 1 June 2020

0 places became available due to parents not accepting the offer of a place.

1 place was offered to a child that has Haywood Village Academy named in a Statement of Special Educational Needs or Education Health and Care Plan, putting the school 1 over PAN. This is a permitted exception to infant class size legislation, under section 2.15 of the school admissions code.

2 places were refused by parents however the school was 1 over PAN due to a permitted exception to infant class size, resulting in only 1 available place for this round of allocations.
