Notice is hereby given that North Somerset Council has made the North Somerset Council (Birnbeck Pier) Compulsory Purchase Order 2020 ("the Order") on 18 September 2020 under Section 47(1)(a) of the Planning (Listed Building and Conservation Areas) Act 1990. It is about to submit the Order to the Secretary of State for Digital, Culture, Media & Sport for confirmation. If confirmed, the Order will authorise North Somerset Council to purchase compulsorily the land described below for the purpose of repairing and restoring Birnbeck Pier and ensuring its future preservation.

Any objection to the Order must be made in writing to the Secretary of State for Digital, Culture, Media & Sport, c/o Planning Casework Unit, 5 St. Philips Place, Colmore Row, Birmingham, B3 2PW, before **Friday 23 October 2020** and should state the title of the Order, the grounds of objection and the objector's address and interests in the land.

**DESCRIPTION OF LAND**

The acquisition of land at and around Birnbeck Pier, Weston Super Mare, to include all interests in:

81380.66 square metres of Birnbeck Island and Grade II\* listed (1129718) Birnbeck Pier, Weston-super-Mare, access way and surrounding waters and sea bed together with hardstanding, former landscaped gardens and paths, buildings, toll gates, car park off Birkett Road leading to Birnbeck Pier and other relevant land, but excluding mines and minerals reserved to The Queen's Most Excellent Majesty.
