**Footpath LA21/31/10, Yatton, North Somerset**  
**Temporary Prohibition of Use by Pedestrians Order 2021**  
**Date coming into force: 16 May 2021**  
**Ref:T20-531/T21-87**

**Notice** is hereby given that North Somerset Council in pursuance of the provisions of section 14 of the Road Traffic Regulation Act 1984, as amended, intend to make an order the effect of which will be to close, temporarily, to pedestrians the length of footpath specified in the Schedule to this Notice. Exemptions are included for works access.

**This order** is required because of the likelihood of danger to the public consequent upon work by Bloor Homes to development works for Bloor Homes (contact Bloor Homes 01793 835 600). This will become operative on **16 May 2021** for a maximum period of 6 months. However, the closures may not be implemented for the whole of the period but only as necessitated by the works which is anticipated to be **6 months** in duration. Appropriate pedestrian traffic signs will be displayed when the measures are in force.

**Schedule** - Footpath LA21/31/10 from North End Road next to Bridge Inn to The Strawberry Line. **Alternative routes** – see one.network
