Allocation Sheet for Clevedon School

National Offer Day (16 April 2021)

Clevedon School has a Published Admission Number of 240.

244 preferences have been received for the school.

After calculating preferences for all schools in North Somerset. Nine children were able to be offered a higher preference school and 235 children were offered Clevedon School. One child was offered a place as a referral. No children were refused a place therefore the oversubscription criteria was not needed. This left four spaces.

Update on 26th April 2021

7 places became available due to parents not accepting the offer of a place and a further place was made available due to a child being offered a higher preference in second round.

14 preferences have been received for the school. It has therefore been necessary to use the oversubscription criteria, as outlined below, to determine which of the applicants should be offered the places available.

In order to be able to offer all in-area applicants a place, Clevedon School exceptionally agreed to increase their intake to 242 for the second round for the 2021 Year 7 intake. This meant that a total of 10 places were available for allocation in the second round.

The 10 available places have been offered to the following applicants:

Update on 17th May 2021

0 places became available due to parents not accepting the offer of a place.

1 preference for the school was received. It has therefore been necessary to use the oversubscription criteria, as outlined below, to determine which of the applicants should be offered the places available.

In order to be able to offer as many in-area applicants as possible, Clevedon School exceptionally agreed to increase their intake to 243 for the third round for the 2021 Year 7 intake. This meant that a 1 place was available for allocation in the third round.
