# Transfer to Secondary School - September 2021

## Allocation Sheet for St Katherine's School

#### National Offer Day (1 March 2021)

St Katherine's School has a Published Admission Number of 180.

421 preferences have been received for the school. It has, therefore been necessary to use the oversubscription criteria, as outlined below, to determine which of the applicants should be offered the places available.

The 180 available places have been offered to the following applicants:

Any applicants not offered a place at the school have been refused because, under the terms of the School Standards Framework Act 1998 (as amended by the Education Act 2011), a place may be refused if the admission of an additional child would cause prejudice to the provision of efficient education or the efficient use of resources.

### Update on 26 April

Following the first round of offers, St Katherine's School informed the Local Authority that they wanted to increase their intake by 6 places over their Published Admission Number in order to meet as many parental preferences as possible for applicants. They then had an intake of 186 for the second round of allocations.



14 places became available due to parents not accepting the offer of a place. 42 applicants were considered for the vacancies.

The places were filled in accordance with the oversubscription criteria as follows:
