SUBJECT: TRANSFER OF ST JOSEPH'S CATHOLIC PRIMARY SCHOOL

KEY DECISION: YES

REASON:

No capital or income involvement exceeding £500,000, but as one of three Catholic schools serving the residents of North Somerset, the school serves pupils that live across more than one ward

BACKGROUND:

The current St Joseph's Catholic Primary School was built in 2001/02. Council holds the freehold title to the land under titles ST202150 and ST247270. St Joseph's Catholic Primary School is a voluntary aided school and The Roman Catholic Diocese of Clifton has exercised its rights under the School Standards and Framework Act (SSFA) 1998 to require the transfer of the School property to the Diocese for nil consideration.

The areas comprising the school property to be transferred are the school buildings and the hard play areas (area outlined in red on the attached plan. This does not include the land for the pre-school (area shaded green) or the soft playing areas (shaded blue). In terms of a decision dated 11th November 2020 (CSD079) the pre-school is in the process of being leased to the Diocese of Clifton for 25 years. In order to ensure adequate access to the pre-school and soft playing area, rights of access and parking will be retained over the area hatched blue on the attached plan.

There is no requirement to transfer the soft playing areas in line with the SSFA 1998.

DECISION:

Officers are authorised to proceed with the transfer the land of St Joseph's Catholic Primary School to the Roman Catholic Diocese of Clifton, being the area outlined red in the attached plan, for no consideration, with access and parking rights retained over the area hatched blue

REASONS:

Required of the School Standards and Framework Act 1998, the contents of which override the council's duty under the Local Government act 1972 to secure best consideration.
