## SUBJECT: ACQUISITION OF ADDITIONAL LAND FOR SPECIAL FREE SCHOOL IN CHURCHILL

## KEY DECISION: YES

## REASON:

The decision affects the lives of vulnerable children across the district.

## BACKGROUND:

Approval was provided in an Executive Member decision dated $9^{\text {th }}$ October 2018, (2018-19 P\&C33) for officers to submit a bid for a Wave 13 Free School Bid to the Department of Education (DfE) to facilitate the establishment of a Social, Emotional and Mental Health (SEMH) Free School within the district. In addition, authority was provided to include a site in Churchill to be included within that bid.

Within the section 151 officer decision dated $13^{\text {th }}$ July 2020 (No. CSD 015), officers were authorised to negotiate and reach agreement regarding the adjoining northern and southern strips of land. Following decision with the Department of Education it was established that only the southern strip of land alongside the existing site would be required for the development. Attached is a plan showing the required land edged red, with the northern strip of land not being required edged blue. The land between these strips being in council ownership and identified for this free school.

Following negotiation with the landowner, Mr and Mrs S Schmollmann, the sum of £15,000 was agreed as the purchase price of the land edged red on the attached plan.

## DECISION:

Officers are authorised to conclude an agreement with the landowners for the acquisition of the red edged land at a price of $£ 15,000$.

## REASONS:

Site required to provide sufficient land for the establishment of this proposed special free school.

Although the agreed price is in excess of normal market values for agricultural land, the need for this land meant that it was, in effect, a ransom strip. In the circumstances, it is officer's opinion that price to be paid in reasonable.
