NORTH SOMERSET COUNCIL **(VARIOUS ROADS, WESTON-SUPER-MARE, NORTH SOMERSET)** **(PROHIBITED MOVEMENTS) ORDER 202#**

As part of the regeneration of Weston-super-Mare's Town Centre, North Somerset Council proposes to introduce a number of prohibited movement restrictions to avoid danger to the public, to facilitate the movement of pedestrians, to prevent damage to the road and to buildings adjacent to the road, and to improve the amenities of the area through which the roads run.

NOTICE OF INTENT

NORTH SOMERSET COUNCIL **(VARIOUS ROADS, WESTON-SUPER-MARE, NORTH SOMERSET)** **(PROHIBITED MOVEMENTS) ORDER 202#**

Notice is HEREBY GIVEN that North Somerset Council (hereinafter referred to as “the Council”) proposes to make an Order under the provisions of the Road Traffic Regulation Act 1984, as amended, (hereinafter referred to as “the Act of 1984”) and of all other enabling powers, the effect of which will be to introduce prohibited movement restrictions for any vehicles, excluding those permitted by way of exemption, on the following roads in Weston-super-Mare: -

- Locking Road – The unnamed link road between Locking Road and Alfred Street
- Marine Parade - The unnamed link road between Richmond Street and Marine Parade
- Alexandra Parade

The Council of North Somerset (hereinafter referred to as "the Council") in exercise of its powers under Sections 84(1) and (2) of the Road Traffic Regulation Act 1984 as amended (hereinafter referred to as "the Act of 1984") and of all other enabling powers, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order: -

1. This Order shall come into operation on ** of ***** 202* and may be cited as the North Somerset Council (Various Roads, Weston-super-Mare) (Prohibited Movements) Order 202#.
2. No person shall cause or permit any vehicle proceeding in any road specified in Column 1 of Schedule 1 to this Order to make a right turn into the road specified in relation to that road in Column 2 of the said Schedule 1 except buses.
3. No person shall cause or permit any vehicle proceeding in any road specified in Column 1 of Schedule 2 to this Order to make a right turn into the road specified in relation to that road in Column 2 of the said Schedule 2 except pedal cycles.
4. No person shall cause or permit any vehicle proceeding in any road specified in Column 1 of Schedule 3 to this Order to make a left turn into the road specified in relation to that road in Column 2 of the said Schedule 3 except buses and hackney carriages.
5. No person shall cause or permit any vehicle proceeding in any road specified in Column 1 of Schedule 4 to this Order to make a left turn into the road specified in relation to that road in Column 2 of the said Schedule 4 except pedal cycles.
6. No person shall cause or permit any vehicle proceeding in any road specified in Column 1 of Schedule 5 to this Order to enter the road specified in relation to that road in Column 2 of the said Schedule 5.
7. No person shall cause or permit any vehicle proceeding in any road specified in Column 1 of Schedule 6 to this Order to enter the road specified in relation to that road in Column 2 of the said Schedule 6 except pedal cycles.
8. Schedules 6, 7 & 8 of the North Somerset District Council (Weston-super-Mare, Seafrent) (Prohibited Movements) Order 2011 are hereby revoked insofar as they relate to the roads or lengths of roads specified in the schedules to this Order.
