Notice is HEREBY GIVEN that North Somerset Council (hereinafter referred to as "the Council") in exercise of the powers conferred by section 90A of the Highways Act 1980 (hereinafter called 'the Act') and of all other enabling powers and after consultation with the chief officer of police in accordance with section 90C (1) of the Act and those bodies or persons prescribed by the Highways (Road Humps) Regulations 1999 (hereinafter called 'the Regulations') and in accordance with section 90C (2) of the Act intends to construct raised tables at the locations specified in the Schedule to this Notice.

The general effect of the notice will be to construct raised tables at the following locations in Weston-super-Mare:

- Outside/near the Town Hall (across the entire width of the carriageway)
Central Point Grid Reference: 332106, 161209
- Outside/near No.19, Alexandra Parade (across the entire width of the carriageway)
Central Point Grid Reference: 332103, 161374
- Outside/near No.28, Alexandra Parade (across the entire width of the carriageway)
Central Point Grid Reference: 332173, 161347
- Outside/near No.38, Alexandra Parade (across the entire width of the carriageway)
Central Point Grid Reference: 332233, 161325
