SUBJECT: LOCAL PLAN PREFERRED OPTIONS - APPROVAL OF CHANGES PRIOR

TO CONSULTATION

KEY DECISION: NO

REASON: This relates to the formal approval of changes to the text of the Local Plan Preferred Options document to take into account changes required by Executive Committee and other amendments required prior to consultation.

BACKGROUND:

The North Somerset Local Plan Preferred Options was approved for the purposes of consultation at Executive Committee on 2 February 2022. The resolution included the delegation of 'any subsequent changes to the document required prior to consultation to the Executive Member for Placemaking and Economy and the Director of Place'. This decision relates to the proposed changes post-committee.

The proposed changes are set out in the attached schedule. They include the two changes agreed at Executive Committee relating to the increase in the affordable housing target to 40% and the inclusion of the proposed primary school adjacent to Drove Road, Weston-super-Mare. The other changes are largely to improve the clarity of the document and include amendments to the climate change and net zero policies to ensure consistence with the approach taken across the West of England, and references added to several of the proposed allocations in relation to transport requirements.

DECISION:

To approve the proposed changes to the Preferred Options document for the purposes of public consultation.
