

Starting School - September 2022

Allocation Sheet for Churchill C of E Primary School

National Offer Day (19 April 2022)

Churchill C of E Primary School has a Published Admission Number of 30.

71 preferences have been received for the school. It has, therefore been necessary to use the oversubscription criteria, as outlined below, to determine which of the applicants should be offered the places available.

The 30 available places have been offered to the following applicants:

The distance between home and school for the last child offered a place was 2.266 miles.

To admit another child to the school would cause prejudice to the provision of efficient education or the efficient use of resources by reason of 'relevant measures', i.e. measures that would be required to be taken in order to ensure that the legal limit on class sizes of one teacher per 30 children is met at the school. Any appeals for places at the school are therefore 'infant class size prejudice cases'.

Update 30 May
