Gordano School has a Published Admission Number of 336. In order to meet as many on time parental preferences as possible for applicants living in the school's First Geographical Area for the 2022-23 intake, the school has exceptionally agreed to take a breach intake of 28 above the Published Admission Number of 336, taking the total intake to 364.

478 preferences have been received for the school. It has, therefore been necessary to use the oversubscription criteria, as outlined below, to determine which of the applicants should be offered the places available.
