Reason:

Financial implications are more than £500,000

Background:

In February 2022, the council was successful in securing funding on the behalf of BNSSG Healthier Together from NHSx to implement a programme of Technology Enabled Care (TEC) projects amongst care providers. The funding was awarded competitively as part of the NHS Unified Digital Grant as one of 11 NHS digital accelerator systems, the only successful system led by a local authority. The application of the equipment is to deliver innovation in our Discharge to Assess / reablement pathways. Successful accelerator sites have been asked to deliver this at pace as part of the ongoing COVID emergency / elective backlog recovery.

Our bid was based on delivering these specific products to achieve specific outcomes and the central monitoring model for Acoustic monitoring will be unique to the UK. We are therefore assisting the NHS in helping them to learn from our implementation and to assist them develop the framework for wide scale implementation across the country over the next few years. The funding is to test and learn at scale and therefore the bulk of the funding for the equipment is from NHSx and no direct funding from NSC will support the Access Your Care operated central monitoring service, which will be funded once fully implemented from subscription.

The value of the one-year service provision and the purchase of the acoustic monitoring equipment to two different providers are values which place them under the PCR 2015 Light Touch provision which allows us to consider the councils CSOs as the procurement guide. Given all of the above and the need to act with some speed, it is proposed that both the purchase of the equipment and the service proposed are decisions awarded with the below CSO exception in mind.

6.3.2 reasons of extreme urgency mean that normal time limits cannot be met, including as a result of unforeseen emergency or disruption to Council services. This may include for example, storm damage to public buildings. Not having sufficient time to tender may not in itself constitute urgency.

The NHS grant of £679,500 will be supplemented by funding set aside by the Council in an earmarked reserve to support post-Covid care provider recovery.

The programme involves the delivery of TEC in four areas:

- 1. Digitisation of Social Care Records;
- 2. Acoustic monitoring in care homes across BNSSG;
- 3. The pilot of use of Advanced Risk Modelling for Early Detection (ARMED) Technicare Solutions Limited, company number 13266108;
- 4. The pilot of use of WHZAN Blue Box (Telehealth) WHZAN Limited, company number 11713530.

The deployment of 600 more units of acoustic monitoring across BNSSG with a central monitoring service funded by subscription by the Care Providers is a unique model for the UK, currently there are three acoustic monitoring suppliers which will all be utilised by the five accelerator systems utilising acoustic monitoring. Given acoustic monitoring is viewed as a key development area by NHSX for care homes, the five accelerator sites will contribute to the development of an NHS framework for acoustic monitoring to be developed for 2023. The central monitoring service will build on overnight care response service operated by Access Your Care one of our strategic domiciliary care providers and submission partner of our successful bid.

Decision:

In accordance with the financial implications section below:

- 1. To approve an addition to the capital programme of £670,250 funded by £457,000 from a capital grant from the NHS and £213,250 from a revenue contribution from the Care Provider Covid Recovery Fund Earmarked Revenue Reserve (ZXB318).
- 2. To increase the adult social care revenue budget by £247,100, with £222,500 funded from a revenue grant from the NHS and £24,600 from the Care Provider Covid Recovery Fund Earmarked Revenue Reserve (ZXB318).
- 3. To note that, should the Care Provider Covid Recovery Fund be insufficient to cover the matched funding costs, further funding is available in the form of the £750k TEC fund that originates from the Council's Disabled Facilities Grant.
- 4. In line with NHS x recommendations and fully funded by the NHS x grant we will purchase and lease to selected care homes across BNSSG 600 units of acoustic monitoring from Adaptive IT at an approximate cost of £489,000.
- 5. In addition, we will commission Access Your Care Limited, company number 07597266 as our bid partner, to develop a central monitoring service for acoustic monitoring funded initially by NHSx funding but subsequently by subscription charges by local care home providers. This service is intended to be self sufficient within twelve months as outlined in the bid detailed in Appendix One.

Reasons:

This decision is required in accordance with Financial Regulations, to ensure that the relevant budgets are increased in accordance with the anticipated spend and funding arrangements

Options Considered:

No significant alternative options

Financial Implications:

The programme of TEC improvements consists of part capital and part revenue costs, funded predominantly by a grant from the NHS, but supplemented by funding from the Innovation Grant element of the Care Provider Covid Recovery Fund, which forms part of the council's earmarked revenue reserves.

The estimated costs and proposed funding arrangements are summarised in the table below and a detailed breakdown is shown in Appendix 1:

The proposals represent a unique opportunity to extend TEC coverage in North Somerset. The bid was multi agency and will see further engagement with care providers to support the initiative. Further consideration of the project is subject to engagement with Primary Care, and Sirona the community health provider

Risk Management:

There is a risk that, given inflationary pressures, the funding may not be able to cover the exact devices and services originally envisaged. However, we are able to vary to quantities to ensure that the funding envelope is not exceeded. In addition, further funding is available from in the form of the £750k TEC fund that originates from the council's Disabled Facilities Grant if required.
