### 1. ELECTION

An Election is to be held of One Parish Councillor for the above ward.

### 2. NOMINATION PAPERS

Nomination papers may be obtained from the offices of the Returning Officer, Town Hall, Walliscote Grove Road, Weston-super-Mare, Somerset, BS23 1UJ who will, at the request of an elector, prepare a nomination paper for signature. ### 3. DELIVERY OF THE NOMINATION PAPERS

Nomination papers must be delivered to the Returning Officer, Town Hall, Walliscote Grove Road, Weston-super-Mare, Somerset, BS23 1UJ, on any working day after the date of this notice between 10am to 4pm but no later than 4 pm on Friday 17<sup>th</sup> June 2022.

### 4. POLL

If the election is contested, a poll will take place on Thursday 14<sup>th</sup> July 2022.

### 5. APPLICATIONS TO REGISTER

Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Tuesday 28<sup>th</sup> June 2022. Applications can be made online: [www.gov.uk/register-to-vote](http://www.gov.uk/register-to-vote).

### 6. ABSENT VOTES

Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Town Hall, Walliscote Grove Road, Weston-super-Mare, North Somerset, BS23 1UJ by 5 pm on Wednesday 29<sup>th</sup> June.

New applications to vote by proxy at this election must reach the Electoral Registration Officer at Town Hall, Walliscote Grove Road, Weston-super-Mare, North Somerset, BS23 1UJ by 5 pm on Wednesday 6<sup>th</sup> July 2022.

Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Town Hall, Walliscote Grove Road, Weston-super-Mare, North Somerset, BS23 1UJ by 5 pm on Thursday 14<sup>th</sup> July 2022. The physical incapacity must have occurred after 5 pm on Wednesday 6<sup>th</sup> July 2022. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5 pm on Wednesday 6<sup>th</sup> July 2022.
