Notice is hereby given that North Somerset Council in pursuance of the provisions of section 14 of the Road Traffic Regulation Act 1984, as amended, have made an order the effect of which will be to close, temporarily, to pedestrians the lengths of footpath specified in the Schedule to this Notice. Exemptions are included for emergency services, works access, works construction vehicles, and as works permit for premises which may only be accessed via the closed section of footpath.

This order was required because of the likelihood of danger to the public consequent upon work by Kier to repair mortuary boundary wall. This will become operative on the 10 October 2022 for a maximum period of six months. However, the closures may not be implemented for the whole of the period but only as necessitated by the works which is anticipated to be of approximately 18 weeks in duration. Appropriate pedestrian traffic signs will be displayed when the measures are in force.

Notice is hereby given that North Somerset District Council in pursuance of the provisions of section 14 of the Road Traffic Regulation Act 1984, as amended, have made an order the effect of which will be to restrict loading and waiting, temporarily, to vehicles the lengths of road specified in the schedules to this notice. Exemptions include for emergency services, for any North Somerset Council vehicle enforcing the restrictions, for statutory undertaker and to allow vehicles to board and alight.

This order is required to improve road safety, provide on street parking areas and to help improve the amenities in the area and became operative on the 12 September 2022 for a maximum period of eighteen months. Appropriate traffic signs will be displayed when the measures are in force.

BAKER STREET (eastern side) – from a point 5m south of its junction with Gerard Road in a southerly direction for 8m. Schedule 3 - Limited waiting parking bays (Mon-Sat, 9am-6pm only. One hour max stay. No return within two hours): BAKER STREET

(northern side) – from a point 33m east from its junction with Alfred Street to a point 55m in an easterly direction. BAKER STREET (northern side) – from a point 3m east of its junction with Wooler Road in an easterly direction for 33m. BAKER STREET (northern side) – from a point 2m east of its junction with Glebe Road in an easterly direction for 17m. Notice is hereby given that North Somerset Council in pursuance of the provisions of section 14 of the Road Traffic Regulation Act 1984, as amended, intend to make an order the effect of which will be to close, temporarily, to vehicles the lengths of roads specified in the Schedule to this Notice. Exemptions are included for emergency services, for any North Somerset Council vehicle enforcing the restrictions and for any vehicle with agreed dispensation from North Somerset Council undertaking emergency work.

The above restriction is necessary in the interest of public safety and the facilitation of road works as part of the Baker Street Active Travel Scheme being undertaken by North Somerset Council.
