This order was required because of the likelihood of danger to the public consequent upon work by Truespeed Communications to lay duct and cable. However, the closures may not be implemented for the whole of the period but only as necessitated by the works which is anticipated to be of 9 days in duration. Exemptions are included for emergency services, works access, works vehicles.

This order was required because of the likelihood of danger to the public consequent upon work by National Grid for towerline removal. This will become operative on the 8 March 2023 for a maximum period of eighteen months. However, the restrictions may not be implemented for the whole of the period but only as necessitated by the works which is anticipated to be of 2 days in duration from 4.30pm on 8 March 2023 to 7pm on 9 March 2023. Appropriate traffic signs and cones will be displayed only when the measures are in force.

Notice is hereby given that North Somerset Council in pursuance of the provisions of section 14 of the Road Traffic Regulation Act 1984, as amended, have made an order the effect of which will be to restrict, temporarily, to pedestrians and vehicles the lengths of footpaths and roads specified in the Schedule to this Notice.

Exemptions for the Prohibition of use by Pedestrians are included for emergency services and for works access. Exemptions for the No Parking, Waiting or Loading restriction are included for emergency services, works access, works vehicles and public transport vehicles picking up and setting down passengers only if works permit.

This order was required because of the likelihood of danger to the public consequent upon work by National Grid Electricity Distribution (South West) for towerline removal. Thirlmere Road - No Parking, Waiting or Loading restrictions on both sides of the road as cones and signs dictate from no 17 to no 25. Alternative routes - see One.Network
