#### **EP Advisory Panel Members**

<u>Secondary Panel Members</u> - stakeholders for which only some initiatives or topics are likely to be relevant. Invited to attend as appropriate (decided by LTAs in consultation with the Chair).

<u>Observing Members</u> - Bus Operators that operate in the EP Area but which are not Primary Panel Members. Observing members can attend meetings but not contribute unless invited by the Chair.
