## Allocation Sheet for Gordano School

### National Offer Day (1 March 2023)

Gordano School has a Published Admission Number of 336.

461 preferences have been received for the school. It has, therefore been necessary to use the oversubscription criteria, as outlined below, to determine which of the applicants should be offered the places available.

The 336 available places have been offered to the following applicants:

The distance between home and school for the last child offered a place was 2.144 miles.

## Update on 24 April
