## Allocation Sheet for Priory Community School – an Academy

### National Offer Day (1 March 2023)

Priory Community School – an Academy has a Published Admission Number of 300.

510 preferences have been received for the school. It has, therefore been necessary to use the oversubscription criteria, as outlined below, to determine which of the applicants should be offered the places available.

The 300 available places have been offered to the following applicants:
