

# Transfer to Secondary School - September 2023

## Allocation Sheet for St Katherine's School

### National Offer Day (1 March 2023)

St Katherine's School has a Published Admission Number of 180.

534 preferences have been received for the school. It has, therefore been necessary to use the oversubscription criteria, as outlined below, to determine which of the applicants should be offered the places available.

The 180 available places have been offered to the following applicants:

Where a school is named in a child's Statement of Special Educational Needs or Education Health and Care Plan, the admission authority is legally required to admit the child to the school. Therefore, such children are allocated places before the admissions criteria, detailed below, are applied.

The distance between home and school for the last child offered a place was 3.503 miles.

## Update on 24 April

9 places became available due to parents not accepting the offer of a place.

St Katherine's School agreed to breach PAN by 8 to maximise parental preference, in order to accommodate as many applicants as possible

76 applicants were considered for the 17 vacancies.

The places were filled in accordance with the oversubscription criteria as follows:
