

Transfer to Secondary School - September 2023

Allocation Sheet for Winterstoke Hundred Academy

National Offer Day (1 March 2023)

Winterstoke Hundred Academy has a Published Admission Number of 150.

319 preferences have been received for the school. It has, therefore been necessary to use the oversubscription criteria, as outlined below, to determine which of the applicants should be offered the places available.

The 150 available places have been offered to the following applicants:

Where a school is named in a child's Statement of Special Educational Needs or Education Health and Care Plan, the admission authority is legally required to admit the child to the school. Therefore, such children are allocated places before the admissions criteria, detailed below, are applied.

The distance between home and school for the last child offered a place was 2.412 miles.

Any applicants not offered a place at the school have been refused because, under the terms of the School Standards Framework Act 1998 (as amended by the Education Act 2011), a place may be refused if the admission of an additional child would cause prejudice to the provision of efficient education or the efficient use of resources.

Update on 24 April

4 places became available due to parents not accepting the offer of a place. 21 applicants were considered for the vacancies.

The places were filled in accordance with the oversubscription criteria as follows:
