## CAF: Back from the Brink: Birnbeck Pier

I am writing to confirm that our Board met on 29th March 2022 and I am pleased to inform you that they decided to award you a grant of up to £3,550,000, (Three Million, Five Hundred and Fifty Thousand pounds) 39% of the total eligible project cost of £9,163,643 towards the first phase of emergency repairs which will enable the 'legs' of the Pier to be stabilised and restored, and for access to be provided across the deck of the Pier.

This award, through the NHMF COVID-19 Response Fund, is made with funds from the Cultural Assets Fund allocated by the Department of Digital, Culture, Media and Sport.

Please be aware that if you spend less on your project than the approved project budget, we will reduce the final grant payable. Any reduction will be in proportion to NHMFs grant contribution. This award is subject to your organisation entering into a contract with the Trustees of the National Heritage Memorial Fund. If the name appearing at the top of this letter is not the formal name of your organisation please let me know straight away.
