

NORTH SOMERSET COUNCIL
(A370 MAIN ROAD, BROCKLEY)
(PROHIBITED MOVEMENT) ORDER 2023

North Somerset Council (hereinafter referred to as "the Council") in exercise of its powers under sections 1(1), 2(1) to (3) and 4(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended (hereinafter referred to as "the Act of 1984"), the Traffic Management Act 2004 as amended (hereinafter referred to as "the Act of 2004") and of all other enabling powers, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following order:-

1. This order shall come into operation on the 6th September 2023 and may be cited as the North Somerset Council (A370 Main Road, Brockley), (Prohibited Movement) Order 2023.
2. In this Order, except where the context requires otherwise, the following expressions shall have the meanings hereby attributed to them:-

“doctor” shall mean a fully qualified and registered medical practitioner as defined in Part II and Part III of the Medical Act 1983, as amended;

“emergency services” shall mean the Police, Ambulance Service, Fire Brigade and Coastguard;

“hackney carriage” is as defined in s80 of the Local Government (Miscellaneous Provisions) Act 1976, s38 of the Town Police Clauses Act 1847 and s4 of the Metropolitan Public Carriage Act 1869 and shall mean a vehicle which is licensed as a hackney carriage under one or more of those enactments or under any similar enactment;

“motor cycle” is as defined in section 185 of the Road Traffic Act 1988;

“pedal cycle” means a cycle (which has the same meaning as that ascribed to it in Section 192 of the Road Traffic Act 1988)

“public service vehicle” is as defined in sections 1 and 82 of the Public Passenger Vehicles Act 1981;

“bus” means a motor vehicle constructed or adapted to carry more than eight passengers (exclusive of the driver)

“local bus” means a motor vehicle constructed or adapted to carry more than eight passengers (exclusive of the driver) operating either a scheduled service registered with the Traffic Commissioner or a School Bus service;

3. No person shall cause or permit any vehicle proceeding in any road specified in Column 1 of Schedule to this Order to make a right turn into the road specified in

relation to that road in Column 2 of the said Schedule.

4. All existing Prohibited Movement Orders are hereby revoked insofar as they relate to the roads or lengths of roads specified in the schedules to this Order.
