## (PROHIBITION OF STOPPING, WAITING, LOADING AND PARKING PLACES) (CONSOLIDATION) ORDER 2022 (VARIATION No.7) ORDER 2023

The North Somerset Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4(1), 36, 45, 46, 49, 53 and 122, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended (hereinafter referred to as "the Act of 1984") and the Traffic Management Act 2004 as amended (hereinafter referred to as "the Act of 2004"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, does hereby make the following Order:

  - a. The provisions and restrictions relating to the locations listed in the Schedule to this Order shall be amended as set out in the Schedule and shown in the plans attached to this Order
  - b. As regards the locations listed in the Schedule to this Order, the plans attached to this Order shall be treated as substituted for the plans for those locations attached to the North Somerset Council (Prohibition of Stopping, Waiting, Loading and Parking Places) (Consolidation) Order 2022
