

## **North Somerset Council Decision**



**Decision Of: Executive Member for Safety in the Community**

**Subject: Area Specific Public Space Protection Orders**

**Key Decision: No**

### **Reason:**

This decision is in relation to renewing and/or amending the localised Area Specific Public Space Protection Orders for individual parks and open spaces across the district. There are no changes or amendments that are considered to be significant in terms of their effect on communities living or working in an area comprising two or more wards in the area of the local authority.

### **Background:**

Public Space Protection Orders (PSPOs) were introduced in North Somerset in October 2017 and are part of the Anti-Social Behaviour, Crime and Policing Act 2014. They are designed to deal with nuisances or problems in a public space that are detrimental to the local community's quality of life.

The orders are reviewed every three years, with the last review taking place in 2020.

This decision notice is only concerned with the localised Area Specific Orders. The decision to renew and make changes to them can rest with the relevant portfolio holder for PSPOs in accordance with the report to Council dated 21 February 2023. The report to Council dated 21 February 2023 can be found in background papers.

A key decision has already been made at the Executive Meeting of the 06 September 2023 to renew all the Area Wide Public Space Protection Orders which are deemed to be significant in terms of their effect on communities living or working in an area comprising two or more wards in the area of the local authority.

### **Decision:**

To renew and/or amend the Localised Area Specific Public Space Protection Orders in accordance with section 60 of the Anti-social Behaviour Crime and Policing Act 2014 as set out in **Appendix 1**.

### **Reasons:**

Public Space Protection orders are only valid for a period of three years from the date at which they were made. All orders in Appendix 1 will not be enforceable if they are not duly made in accordance with section 60 of the Anti-social Behaviour, Crime and Policing Act 2014.

### **Options Considered:**

**Not renew the existing localised Areas Specific PSPOs** – PSPOs must be reviewed every three years. Failure to do so would result in the orders not being in force which will limit our ability to effectively deal anti-social behaviour in our public spaces.

### **Not introduce any new or amended PSPOs and just renew what we already have –**

We have been working with councillors and officers from across council departments (including, for example, community safety, environmental health, parks, equalities, legal), police colleagues, external agencies and other key stakeholders, including Town & Parish Councils to help draft the Public Space Protection Orders (PSPOs) based on first-hand experience of having to handle antisocial behaviour issues within our communities. Failure to introduce the orders in line with the recommendations will limit our ability to effectively deal with the issues.

### **Financial Implications:**

There is an ongoing requirement to maintain adequate signage at the locations affected by the orders.

### **Costs:**

The costs of signage will be met through existing budget provision.

### **Funding:**

N/A

### **Legal Powers and Implications:**

PSPOs were brought in under the Anti-Social Behaviour, Crime and Policing Act in 2014. They were first introduced in North Somerset in 2017 and then renewed for a further three years in 2020. Approval of this decision will mean the orders will now be valid until October 2026. Any new or varied PSPOs can be challenged in the high court within a period of six weeks following introduction.

North Somerset Council has not been challenged on any of the orders that have been introduced to date. However, any new or amended PSPOs listed in Appendix 1 will be open to challenge within the first six weeks of adoption.

Revised guidance issued in March 2023 helps police and councils to continue to take appropriate action against nuisance behaviours while ensuring the most vulnerable, including the homeless, are not disproportionately targeted.

This guidance follows feedback from charities and other groups who raised concerns nationally that the orders were being used in some cases to disproportionately target certain groups in some areas rather than focusing on behaviour that is genuinely anti-social and causing others distress or alarm.

Concerns were raised around the use of the orders against the homeless, buskers, dog walkers and, in some cases, people simply gathering in small groups in town centres who were not engaged in anti-social behaviour.

The guidance puts greater emphasis on the need to ensure the powers are used to target specific nuisance behaviours and are not applied in a blanket way against specific groups or behaviour that is not in itself anti-social. It reminds councils that powers should not, for example, target normal everyday behaviour that is not having a detrimental effect on the community's quality of life.

Where young people are concerned, councils should think carefully about restricting activities that they are most likely to engage in. Restrictions that are too broad or general in nature may force the young people into out-of-the-way spaces and put them at risk. In such circumstances, councils should consider whether there are alternative spaces that they can use.

Any proposals considered for approval will be subject to legal review and approval before coming into force, any changes to wording which substantially alters the meaning of a provision will be subject to further consultation.

### **Climate Change and Environmental Implications:**

The orders, whilst introduced mainly to tackle anti-social behaviour issues in our communities, they do also offer considerable benefit to the environment by tackling low level environmental crime

### **Consultation:**

The council undertook a public consultation between 05 June 2023 and 30 July 2023. The consultation was hosted on the council's consultation system e-Consult.

A dedicated email inbox was set up and was monitored daily and paper copies were sent out on request.

The consultation was further promoted through press releases and social media coverage and through the councils own internal publication methods.

The council also consulted with Avon & Somerset Constabulary, including the Police and Crime Commissioner. The police and the council have shared information about the issues raised by our communities and will be working together through a Memorandum of Understanding (MoU) to enforce the PSPOs.

We have also engaged with Town & Parish Council's in whose areas these orders exist or are proposed.

The full details of the results are retained by the Safer Communities Enforcement Manager and Environmental Protection Service Leader.

**Risk Management:**

According to the risk scoring matrix as set out in the council's Risk Management Strategy, the risk is considered to be high if the recommendations set out in this decision notice are not implemented. This is because there will be a high possibility of adverse impact to residents in localised areas due to the prevalence of Anti-social Behaviour without adequate measures in place to control it. The recommendations if approved will mitigate this risk by maintaining our ability to effectively deal with Anti-social Behaviour in these parks and open spaces. Therefore if recommendations are approved, the residual risk is considered to be low/medium.




