

# Anti-Social Behaviour, Crime and Policing Act 2014

## North Somerset District Council (Public Libraries, Children's Centres, Recycling Centres and Council Buildings) Public Space Protection Order 2023

1. This Order may be cited as the North Somerset District Council (Public Libraries, Children Centres, Recycling Centres and Council Offices) Public Space Protection Order 2023
2. This Order shall commence on the date it is made and cease to be of effect on the 12 October 2026.
3. This Order applies to the public spaces specified in Schedule 1 and imposes restrictions as set out in Schedule 2.
4. It is an offence for a person, without reasonable excuse:
  - (a) to do anything a person is prohibited from doing by schedule 2 of this order, or
  - (b) to fail to comply with a requirement to which the person is subject by schedule 2 of this order
5. A person guilty of an offence under condition (a) or (b) of article 4 of this order, is liable on summary conviction to a fine not exceeding level 3 on the standard scale or fixed penalty notice of a maximum of £100.

## **Schedule 2**

### **Restrictions**

1) No person shall

(a) cause damage to property

(b) behave in an intimidating, disorderly or indecent manner on the premises, use intimidating, abusive, offensive, insulting or obscene language or gestures therein, or intentionally or recklessly cause or do anything likely to cause injury to any other person.

(c) intentionally or recklessly obstruct any member of staff in the execution of his or her duty or intentionally or recklessly disturb, obstruct, interrupt or abuse any other person properly using the premises.

(d) without consent of the manager of the facility on that day, intentionally display, distribute, or leave any flyer, placard, notice or other document on the premises.

(e) intentionally view offensive and inappropriate material

(f) without consent of the manager of the facility on that day, offer anything for sale or seek donations on the premises or canvass or seek signatures for petitions.

(g) smoke, including electronic cigarettes, on the premises except in an area specifically set aside for smoking.

(h) fail to leave the property or premises when requested to do so by a member of staff.

(i) fail to follow site or staff instructions

(j) except with consent of the manager of the facility on that day:

cause or allow any dog (other than an assistance dog) or other animal to enter or remain in the premises;

(k) bring into any part of the building a wheeled vehicle or conveyance other than those necessary for the assistance of people with limited mobility, including children for which a pushchair is required.

(2) If a Police Constable or Authorised Person reasonably believes that a person has acted contrary to the restrictions placed upon them by this Order, they must provide their name and address when required to do so.
