**(PROHIBITION OF STOPPING, WAITING,
LOADING AND PARKING PLACES)
(CONSOLIDATION) ORDER 2022 (VARIATION No.8) ORDER 2024**

North Somerset Council (hereinafter referred to as “the Council”) in exercise of its powers under Sections 1(1), 2(1) to (3), 4(1), 36, 45, 46, 49, 53 and 122, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended (hereinafter referred to as “the Act of 1984”) and the Traffic Management Act 2004 as amended (hereinafter referred to as “the Act of 2004”), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, does hereby make the following Order:

1. THIS ORDER shall come into operation on the XX XXXX 2024 and may be cited as the North Somerset Council (Prohibition of Stopping, Waiting, Loading and Parking Places) (Consolidation) Order 2022 (Variation No.8) Order 2024. For Weston-s-Mare.
2. The plans attached to this Order in hard copy form indicate the sides or lengths of roads on which the provisions of this Order apply and specify further particulars of the restrictions that are referred to in this Order. Those plans are stored on the Council’s “Streets” digital mapping system which has been used to print the hard copies attached to this Order.
3. The North Somerset Council (Prohibition of Stopping, Waiting, Loading and Parking Places) (Consolidation) Order 2022 is hereby varied as follows:
 - a. The provisions and restrictions relating to the locations listed in the Schedule to this Order shall be amended as set out in the Schedule and shown in the plans attached to this Order
 - b. As regards the locations listed in the Schedule to this Order, the plans attached to this Order shall be treated as substituted for the plans for those locations attached to the North Somerset Council (Prohibition of Stopping, Waiting, Loading and Parking Places) (Consolidation) Order 2022

Street Name	Description of Proposals	Plan Ref
Stafford Road, Weston-super-Mare	Install approximately 9 metres of double yellow lines on the corner of No.33	Plan 1
Stafford Road, Weston-super-Mare	Install approximately 30 metres of double yellow lines in front of No.42 – No.50	Plan 1
Stafford Road	Install approximately 4 metres of double yellow lines across the lane between No.38 – No.40	Plan 1
Stanley Grove, Weston-super-Mare	Install approximately 5 metres of double yellow lines across the lane between No.19 & No.21	Plan 1
