 - b. As regards the locations listed in the Schedule to this Order, the plans attached to this Order shall be treated as substituted for the plans for those locations attached to the North Somerset Council (Prohibition of Stopping, Waiting, Loading and Parking Places) (Consolidation) Order 2022
