Schedule 1 30mph Speed Limit

WRINGTON ROAD

From its junction with A370 Bristol Road to a point 18 metres north of the centre point of its junction with Wrington Lane

WOOD HILL

- From its junction with A370 Bristol Road to a point 63 metres north-west of this junction.

Schedule 2 40mph Speed Limit

WOOD HILL

- From a point 63 metres north-west of its junction with A370 Bristol Road to Its junctions with B3133 Smallway and Frost Hill.

STATEMENT OF REASONS

NORTH SOMERSET COUNCIL (WOOD HILL AND WRINGTON ROAD, NORTH SOMERSET) (SPEED LIMITS) ORDER 2024

As part of its approved Bus Service Improvement Plan (BSIP), North Somerset Council proposes to introduce a 30mph speed limit on a small section of Wood Hill prior to its junction with the A370. Furthermore, the speed limit on Wrington Road prior to its junction with the A370 will be reduced to 30mph.

The proposed speed limit changes to 30mph are intended to avoid danger to persons or other traffic using the roads and to be consistent with the new speed limits on the A370 at these points.

The Council of North Somerset (hereinafter referred to as "the Council") in exercise of its powers under Sections 81, 82(2), 83(2), 84(1) and (2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended (hereinafter referred to as "the Act of 1984") and of all other enabling powers, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- 1. This Order shall come into operation on the **th ******202* and may be cited as the North Somerset Council (Wood Hill and Wrington Road, North Somerset) (Speed Limits) Order 2024.
- 2. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of road specified in Schedule 1 to this Order.
- 3. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of road specified in Schedule 2 to this Order.
- 4. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces)(Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
- 5. The County Council of Avon (Various Roads, Congresbury and Yatton, District of Woodspring) (Restricted Roads) (40 M.P.H. Speed Limit) Order 1996 by virtue of which:
 - i) a speed limit of 40 miles per hour was imposed on the lengths of road specified in Part 1 of Schedule 3 to this Order; and

is hereby revoked insofar as it relates to those lengths of roads.

WOOD HILL - From a point 63 metres north-west of its junction with A370 Bristol Road to Its

SCHEDULE 3 Lengths of road to be revoked

Part I

WRINGTON ROAD - That length of Wrington Road which

extends from its junction with the A370 Bristol Road is a south easterly direction to a point 20 metres north west of its junction with Wrington Lane, a distance measured along the said length of road of

approximately 300 metres

WOOD HILL - The whole length of Wood Hill which extends from its junction with the B3133 Frost Hill and Smallway to its junction

with the A370 Bristol Road, a distance measured along the said length of road of

approximately 800 metres.
