Prohibition Of Motor Vehicles (School Streets) Order 2023

Notice is hereby given that on the 21 December 2023, North Somerset Council made the following order in exercise of its powers under the Road Traffic Regulation Act 1984 as amended. The general effect of which will be to prohibit motor vehicles to enter or proceed on that length of Road as specified in the Schedule to this Notice, with an exemption for pedal cycles and vehicles gaining access to properties.

The order comes into operation on the 4 January 2024 and copies of this together with plans and a copy of the Council's statement of reason for making the order may be inspected at North Somerset Council website by using the following address:

Any person who desires to question the validity of, or of any provision contained in the order on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 as amended, or on the grounds that any of the relevant requirements of that Act has not been complied with in relation to the order, may within six weeks after the date on which the order was made, apply to the High Court for this purpose.

Schedule 1 - Prohibition of Motor Vehicles, Monday to Friday 8.15am - 9.15am and 2pm – 4pm (except for pedal cycles), Greenfield Park the entire length. Schedule 2 - Prohibition of Motor Vehicles, Monday to Friday 8.15am – 9.15am and 2.30pm – 3.30pm (except for pedal cycles), Westfield Drive the entire length. Schedule 3 - Prohibition of Motor Vehicles, Monday to Friday 8.15am - 9.15am and 2.45pm – 3.45pm (except for pedal cycles), Highdale Avenue from a point 256m east of its junction with Chapel Hill to its termination with the boundary of St Nicholas Chantry School. Schedule 4 - Prohibition of Motor Vehicles, Monday to Friday 8.15am - 9.15am and 2.45pm - 3.45pm (except for pedal cycles), Tudor Road the entire length, Norfolk Road the entire length, Forester Road the entire length, Cotswold Close the entire length, Richmond Close the entire length, Halletts Way the entire length.
