In person – via appointment only during office hours (Monday – Friday). Please do not turn up on the day and expect your application to be processed without prior appointment. No permits will be issued on weekends.

Via email – Please email completed Application Form and Public Liability Insurance certificate (minimum cover £5million) to <u>seafront.office@n-somerset.gov.uk</u> After your application has been checked, you will receive a call from the Seafront team to make payment. Once received, the Seafront Rangers will be issued with your permit to distribute on the slipway.

By post – North Somerset Council, Tropicana Office, Marine Parade, Weston-super-Mare, BS23 1BE **NOTE**: Permit will <u>not</u> be issued without evidence of valid Public Liability Insurance cover.

Agreement

I hereby agree to familiarise myself with and abide by the directions of North Somerset Council Officers and comply with North Somerset Council's Rules and Directions at all times.

I undertake to maintain appropriate **Public Liability Insurance** to the minimum value of **£5m** for the duration of this permit and **attach a copy of my policy certificate**.

I understand that this permit is non-transferable and that I am responsible for renewing it if I wish to have continued use of the Slipway. **Annual permits are valid from 1 April – 31 March**

I confirm that my Craft ID / Permit ID sticker will be visibly displayed on my vehicle and trailer when using the Slipway.

I take full responsibility for my own actions and the actions of any named and / or permitted drivers and absolve North Somerset Council from any liability for damage sustained to me, my property and / or users of my craft, damage to a third party or their property whilst accessing the Slipway, launching, using my craft or exiting the site. I understand that failure to comply with the above directions and user regulations will result in further action and could result in withdrawal of my permit to launch from North Somerset Council owned and managed sites.
