

NORTH SOMERSET COUNCIL

**(VARIOUS ROADS, A370, CLEEVE AND BROCKLEY, NORTH
SOMERSET)
(SPEED LIMITS) ORDER 2024**

The Council of North Somerset (hereinafter referred to as “the Council”) in exercise of its powers under Sections 81, 82(2), 83(2), 84(1) and (2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended (hereinafter referred to as “the Act of 1984”) and of all other enabling powers, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into operation on the 29th April 2024 and may be cited as the North Somerset Council (Various Roads, A370, Cleeve and Brockley, North Somerset) (Speed Limits) Order 2024
2. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of road specified in Schedule 1 to this Order.
3. No person shall drive any motor vehicle at a speed exceeding 50 miles per hour on the lengths of road specified in Schedule 2 to this Order.
4. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
5. The County Council of Avon (A370 Main Road, Brockley and Cleeve, District of Woodspring) (40 MPH Speed Limit)(50 MPH Speed Limit) Order 1995 by virtue of which the length of Road Specified in Schedule 3 in this order became subject to a 50mph Speed Limit, is hereby revoked.
6. The North Somerset District Council (A370 Bristol – Weston-Super-Mare), (Speed Limit) Order 2001 by virtue of which the length of Road Specified in Schedule 4 in this order became subject to a 50mph Speed Limit, is hereby revoked.

SCHEDULE 1
40mph Speed Limit

A370 (RHODYATE HILL, MAIN ROAD)

- From a point 256 metres north-east of the centre point of A370 Rhodyate Hill's most south-western junction with Rhodyate Lane to a point 25 metres north-east of the centre point of A370 Main Road's junction with Chelvey Batch's most south-western junction.

SCHEDULE 2
50mph Speed Limit

A370 MAIN ROAD

- From a point 25 metres north-east of the centre point of A370 Main Road's junction with Chelvey Batch's most south-western junction to a point 47 metres south of the centre point of A370 Main Road's junction with Kellways.

SCHEDULE 3
50mph Speed Limit to be revoked

A370 MAIN ROAD

- That length of the A370 Main Road which extends from a point 180 metres north east of its southernmost junction with Chelvey Batch to a point 100 metres north east of its junction with the access road to Brockley Church, a distance measured along the said length of road of approximately 910 metres.

SCHEDULE 4
50mph Speed Limit to be revoked

BROCKLEY

- **Main Road (A370)** – from a point 180 metres north east of its southernmost junction with Chelvey Batch extending to a point 40 metres south of its junction with Kellways, a distance of approximately 860 metres.
