

## **NORTH SOMERSET COUNCIL**

### **(VARIOUS ROADS, A370, CONGRESBURY, NORTH SOMERSET)** **(SPEED LIMITS) ORDER 2024**

The Council of North Somerset (hereinafter referred to as “the Council”) in exercise of its powers under Sections 81, 82(2), 83(2), 84(1) and (2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended (hereinafter referred to as “the Act of 1984”) and of all other enabling powers, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into operation on the 29<sup>th</sup> April 2024 and may be cited as the North Somerset Council (Various Roads, A370, Congresbury, North Somerset) (Speed Limits) Order 2024
2. The lengths of road specified in Schedule 1 to this Order shall be restricted roads for the purposes of Section 81 of the Act of 1984.
3. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of road specified in Schedule 2 to this Order.
4. No person shall drive any motor vehicle at a speed exceeding 50 miles per hour on the lengths of road specified in Schedule 3 to this Order.
5. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
6. The North Somerset District Council (A370 Bristol Road, Congresbury) (Speed Limit) Order 2010 by virtue of which the length of Road Specified in Schedule 4 in this order became subject to a 30 mph Speed Limit, is hereby revoked.
7. The North Somerset District Council (A370 Bristol Road, Congresbury) (Speed Limit) Order 2010 by virtue of which the length of Road Specified in Schedule 5 in this order became subject to a 40 mph Speed Limit, is hereby revoked.
8. The North Somerset District Council (A370 Bristol Road – Weston-Super-Mare) (Speed Limit) Order 2001 by virtue of which the length of Road Specified in Schedule 6 in this order became subject to a 40 mph Speed Limit, is hereby revoked.
9. The North Somerset District Council (A370 Bristol Road – Weston-Super-Mare) (Speed Limit) Order 2001 by virtue of which the length of Road Specified in Schedule 7 in this order became subject to a 50 mph Speed Limit, is hereby revoked.

**Schedule 1**  
**Restricted Roads**

**A370 (RHODYATE HILL, BRISTOL ROAD, STATION ROAD, WESTON ROAD)**

- From a point 176 metres north of the A370 Bristol Road's Junction with Wrington Road, to A370 Bristol Road's intersection with Station Road and High Street, Congresbury at the central point of the junction.

**Schedule 2**  
**40mph Speed Limit**

**A370 RHODYATE HILL**

- From a point 176 metres north of the A370 Bristol Road's Junction with Wrington Road, to a point 284 metres south-west of A370 Rhodyate Hill's most south-western junction with Rhodyate Lane.

**Schedule 3**  
**50mph Speed Limit**

**A370 RHODYATE HILL**

- From a point 284 metres south-west of A370 Rhodyate Hill's most south-western junction with Rhodyate Lane to a point 254 metres north-east of this same junction

**Schedule 4**  
**30mph Speed Limit to be revoked**

**CONGRESBURY  
Bristol Road (A370)**

- from a point 135 metres north-east of the point at which the prolongation of the south kerbline of the A370 Bristol Road and the prolongation of the east kerbline of the (north easternmost junction of) B3169 Kent Road would intersect, in a south westerly direction for a distance of approximately 734 metres

**Schedule 5**  
**40mph Speed Limit to be revoked**

- CONGRESBURY  
Bristol Road (A370)** - From a point 135 metres north-east of the point at which the prolongation of the south kerbline of the A370 Bristol Road and the prolongation of the east kerbline of the (north easternmost junction of) B3169 Kent Road would intersect, in a north easterly direction for a distance of approximately 116 metres

**Schedule 6**  
**40mph Speed Limit to be revoked**

- CONGRESBURY  
(b) Rhodyate Hill  
(A370)** - From its junction with the Wrington Road in a northerly direction for a distance of approximately 200 metres northwards

**Schedule 7**  
**50mph Speed Limit to be revoked**

- CONGRESBURY/  
CLEEVE  
Rhodyate Hill  
(A370)** - From 200 metres north of Wrington Road to 60 metres south west of the north east junction of Rhodyate Lane with the A370, a distance of approximately 930 metres
