### National Offer Day (16 April 2024)

The school has a Published Admission Number (PAN) of 60.

126 preferences have been received for the school. It has, therefore been necessary to use the oversubscription criteria, as outlined below, to determine which of the applicants should be offered the places available.

The places have been offered to the following applicants:

The distance between home and school for the last child offered a place was 1.246 miles, as measured in a direct line.

Any applicants not offered a place at the school have been refused because there were more applications received than places available at the school. The oversubscription criteria was applied to determine who qualifies for a place.
